

## Terms & Conditions for a temporary online trial or collaboration access to Karger online publications

- 1. Permitted Uses to the Trial Licensee (respectively, Collaboration License) and to the Authorized Users<sup>1</sup>:
  - a) To make single print or electronic copies of single articles for personal, scholarly, educational, scientific research or internal business use, which explicitly excludes storage on an internal article database/ archive
  - b) To search, view, retrieve and display single articles for personal, scholarly, educational, scientific research or internal business use
  - c) To make such temporary local electronic copies by means of cacheing or mirrored storage of any part of Karger online publication as is necessary solely to ensure efficient use by authorized users.
  - d) To allow Authorised Users to have access to Karger online publications through a secure Network or proxy server of the institution.
  - e) Distribute single copies of individual items from Karger online publications in print or electronic format to other Authorized Users.

## 2. Prohibited Uses:

Neither Licensee nor Authorized Users may:

- a) Remove or alter the authors' names or affiliations or the Karger's copyright notices or other means of identification or disclaimers as they appear in Karger online publications
- b) Alter, abridge, adapt or modify any part of Karger online publications for any purpose other than that expressly permitted by this Licensee, except to the extent necessary to make it perceptible on a computer screen to Authorized Users. For the avoidance of doubt, no alteration of the words or their order is permitted
- c) Systematically make print or electronic copies of multiple extracts of Karger online publications for any purpose other than explicitly permitted
- d) Systematically download Karger online publications, especially operated by an application server/robot,
- e) for any purpose other than explicitly permitted

<sup>&</sup>lt;sup>1</sup> "Authorized Users" shall mean an individual who is authorized to access Karger online publications through a Secure Network or proxy server at an institution with a temporary online trial access. Such individuals might be either a current employer or employee of a clinical center, a governmental, research or comparable entity; in case of an academic institution a current student, faculty member, library patron or employee (Academic User) via his/her affiliation with an institution.



- f) Mount or distribute any part of the Karger online publication on any electronic network, including, without
- g) limitation, the Internet and the World Wide Web, other than the Secure Network
- h) Integrate Karger online publications with any other material or otherwise create derivative works in any
- i) format and/or medium
- 3. The Trial Licensee, respectively, free collaboration licensee has to ensure that:
  - a) Access is provided to Authorized Users exclusively
  - b) All Authorized Users are appropriately notified about the requirement to respect the intellectual property rights of Karger online publications and that they are made aware of and undertake to abide by the usage conditions
  - c) Reasonable steps are taken to protect the Materials from unauthorized use.
